COUNCIL OF THE TOWNSHIP OF MONROE MINUTES AGENDA MEETING – SEPTEMBER 30, 2013

The Council of the Township of Monroe met in the Municipal Building, 1 Municipal Plaza, for an Agenda Meeting.

The Agenda Meeting was Called to Order at 7:00 p.m. by Council President Gerald W. Tamburro with a Salute to the Flag.

<u>Councilman Dalina</u> – reported that "Octoberfest" will be held on Oct. 20th at the Community Center from 12-4pm.

<u>Councilwoman Koppel</u> – mentioned that the "Green Fair" will be held this Oct. 5th from 10am-3pm.

<u>Council Vice-President Miller</u> – talked about the "Old Time Baseball Game" that was held at the Dey Farm with 75-80 people present.

<u>Council President Tamburro</u> – also mentioned the Old Time Baseball Game, in which he threw out the 1st ball. Saturday will be the "Green Fair" and this Saturday at noon there will be a reenactment and celebration of Monroe's 175th Anniversary. Rossmoor has a 5K Run later in the day as cancer fund raiser.

Council President Tamburro then reported on the Energy Aggregation meetings and how well received they were, with a major concern being the risk and reward. This is a question that cannot yet be answered. There will be another mailing this month. It will then give the JCP&L customers the opportunity to opt-out if they so choose. There also will be an opportunity for residents with 3rd party providers to opt-in. It is anticipated that we will be going out to bid by Nov. 14th. It will be a fixed rate for a period of time of no less than 12 months and no longer than 24 months.

PUBLIC:

<u>Charles Petretti</u>, 4A Wingate Ct. – would like clarification on Items 8.h. & 8.i. Item 8.h. is regarding RFQ's for Various Professionals for 2014 for MTUD and Item 8.i. is for authorization to prepare specs and advertise for receipt of bids for various goods and services for the MTUD.

Mr. Petretti asked if the Purchasing Manager was handling both items and Administrator Hamilton responded that Tim Stoessler, the Purchasing Agent for MTUD, will be handling both.

Item #8.g. – Professional Service Contract with Maser Consulting for construction engineering services & observation services relating to the Route 33 Deceleration Lane Project; asked for an explanation. Administrator Hamilton explained that the State requires that since we are doing work on a State Highway, an independent agency must be employed to inspect & oversee the work being performed. The fee is in an amount not to exceed \$40,000.

Item #8.I. – Settlement Agreement in connection with the Community Center. Administrator Hamilton explained the circumstances of closing this project out.

Item #8.n. – Purchase of (2) Motor Vehicles for the MTUD – asked if they would be for personal use to which Administrator Hamilton explained that one is a pick-up truck and the other a cargo van, which are not for personal use.

He next asked about development in the town and if there are a projected number of homes to be developed over the next 5-7 years in the form of senior housing, individual housing, multiple unit housing, and low income housing. He believes this is going to be a serious matter to deal with in the next 5-7 years in terms of education in this town. He himself has added up 3,000 units of various types over the next 5-7 years.

Various developments were named with Administrator Hamilton mentioning that the Stratford approval was gotten over 15+/- years ago. He feels that the question is, has the School properly planned for the growth and build-out of those homes. Certainly their demographer speaks with the Planning Department to get an idea of what developments have been approved and what is not built yet. These questions need to be addressed by the Board of Education.

<u>Tom Nothstein</u>, 15 Nathaniel St.- Item #6.a. – Amendment to Chapter 108 (Blk. 35; Lots 6.01 & 6.02) asking when there will be deliberative talks about this item.

Council President Tamburro responded that, as he previously stated, there has to be a substantial agreement between the developer and the people with concerns. He has heard from the Manager of Regency, who stated there is another group of residents in favor of this proposal. The town is waiting until next Monday's meeting for responses from all concerned.

Item #7. – Acquisition of portions of and easements to Block 18, Lots 14.5 & 14.7 and Block 27.6, Lot 27.6 – asking for the location and what it is needed.

Council President Tamburro responded that it is right-of-ways at the intersection of Perrineville Road and Union Valley Road for a Traffic Light.

Mr. Nothstein then asked for the status of the COAH Trust Fund monies and Council President Tamburro responded that on a regular basis there are rent subsidies that are paid and remediations for private homes for qualified residents for Affordable Housing. Monies are still in the "Irrevocable Trust" which is slightly under eleven million dollars. As developers build, monies are put in the trust.

Mayor Pucci stated that we are anticipating Round 3 within the next five months. A new COAH Board will be established as well as a possible new formula.

<u>Michele Arminio</u>, 9 Nathaniel St. – asked if Mr. Rogers had a T3/T4 License and Administrator Hamilton responded "no" he did not. Mr. Barnes, who is a professional engineer and here this evening, has taken over the position and has T3/T4 licenses. She asked if there was anyone in the Utility Department that had the T4 license. Council President Tamburro responded that the Water Superintendent has a T4 license. The State now requires that there be at least (2) T-4's employed. She asked when the change came about and Council President Tamburro responded "April 2013".

She asked about the term of Middlesex Water's (Utility Services Associates) contract and was told it is for one year.

UPON MOTION made by Councilman Dalina and seconded by Councilman Leibowitz, the meeting was Adjourned at 7:30pm.
