**ORDINANCE OF THE MONROE TOWNSHIP COUNCIL  
AMENDING ORDINANCE NO. O-5-2018-017 ENTITLED,  
“ACKNOWLEDGING MONROE TOWNSHIP’S ACCEPTANCE OF  
THE TRAFFIC SIGNAL LOCATED AT THE INTERSECTION OF  
PERRINEVILLE ROAD (CR 625) AND FEDERAL ROAD”**

**BE IT ORDAINED**, by the Township Council that Ordinance No. O-5-2018-017 needs to be revised to correct a typographical error and to correctly identify by title the Post Construction Timing Result report as required by Middlesex County; and

**BE IT FURTHER ORDAINED** by the Township Council of the Township of Monroe, in the County of Middlesex, State of New Jersey the corrected Ordinance is as follows:

**SECTION 1.** The intersection of Perrineville Road (County Road 625) and Federal Road shall be controlled by a Traffic Control Signal in accordance with the As-Built Traffic Signal Plan bearing the date of February 6, 2018, and the Post Construction Timing Results bearing the date of June 1, 2017.

**SECTION 2.** The Traffic Control Signal shall be in accordance with the provisions of the Manual of Uniform Traffic Control Devices, Title 39 of the Revised Statutes and the New Jersey Administration, County Standards and ADA Standards. Said Traffic Control Signal shall be operated in conformance with the designated Plan.


**SECTION 3.** All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance shall be and the same are hereby repealed.

**SECTION 4.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 5.** This Ordinance shall take effect upon final passage and publication as provided by law.

**SECTION 6.** Upon final passage and adoption, the Township Clerk shall forward two certified copies of this Ordinance to Richard Wallner, PE, Middlesex County Engineer, P.O. Box 871, 333 Townsend Street, New Brunswick, N.J. 08903, the Middlesex County Planning Board and to the Middlesex County Board of Chosen Freeholders for a consenting resolution.


