### APPLYING FOR A RAFFLE LICENSE

- 1. The Organization applying for a Raffle license must have a valid Certificate of Registration with the State of New Jersey, Legalized Games of Chance Control Commission. (Registration is valid for (2) two years) and must be within the raffle period.
- 2. The Application for a Raffle License, as well as the required paperwork, must be submitted in sets of four (4). The application may be copied, but the signatures required as well as notary on the last page, **must be original signatures**. There must be at least two (2) signatures, **an Officer of the Organization and a Member** of the Organization.
- 3. The application must be submitted (6) weeks prior to the event.
- 4. Along with the applications, the following is required:
  - (a) Applications need to be submitted at least (6) weeks prior to the event.
  - (b) The Clerk's Office must see the **original Certificate of Registration** for the Organization.
  - (c) A sample ticket if applying for an **Off-Premise Raffle**. (See Attached Sample Ticket)
  - (d) Two Checks. (See Attached Fee Schedule)
    - State Fees payable to "Legalized Games of Chance Control Commission"
    - Municipal Fee payable to "Township of Monroe"
  - (e) Photo ID of member or members-in-charge.
- 5. Once the full application has been processed by the town and a Police background check has been received, the application will be forwarded to the State of New Jersey, Legalized Games of Chance Control Commission. The state has fifteen (15) business days from the date of receipt to accept or deny approval of your application. If your application is accepted, you will not hear from them. You will receive a complete copy of the application. An end of raffle report must be filed with the State and the Township. A copy of this form is included in your packet. You must also include a check if your raffle ticket sales have exceeded your anticipated sales.



### SPECIAL DOOR PRIZE RAFFLE:

No Fee and no license, provided the merchandise is wholly donated and has a retail value of less than \$50.00. Note: cannot be conducted when other games of chance are being conducted, held or operated.

### **CALENDAR RAFFLE:**

\$20.00 to the State and Township (for each \$1000. Or part thereof of the retail value of the prize.)

### **INSTANT RAFFLE:**

- \$20.00 to the State and Township for each day on which instant raffle tickets are sold or offered for sale or
- \$750.00 to the State and the Township for a one year license.

GOLF HOLE-IN-ONE - \$20.00 to the State and the Township (for each \$1000 or part thereof of retail value of ancillary prizes.).

ARMCHAIR RACE: \$50.00 to the State and the Township per licensed day of operation.

CASINO NIGHTS: \$100.00 to the State and the Township per occasion.

NOTE: Fees for ON-PREMISES DRAW RAFFLES, OFF-PREMISES DRAW RAFFLES, NON-DRAW RAFFLES and BINGO are due in full at the time the application is filed with the municipality.

Fees for OFF PREMISE DRAW RAFFLES - A \$20.00 fee to the State and the Township is due at the time the application is filed and, if the awarded prize(s) exceed \$1,000., an additional fees are due according to the chart posted on the front page upon the filing of the Report of Raffles Operation.

CHECKS for STATE FEES must be made payable to "LEGALIZED GAMES OF CHANCE CONTROL COMMISSION" and CHECKS for MUNICIPAL FEES must be made payable to "TOWNSHIP OF MONROE".
