**BE IT ORDAINED,** by the Mayor and Township Council of the Township of Monroe, County of Middlesex, State of New Jersey, that Chapter 97 "Tree Preservation" §5 entitled "Tree Removal Permits" of the Code of the Township of Monroe shall be amended and supplemented to read as follows: (new text is in red and <u>underlined</u>, text to be deleted is <del>struck</del>)

Section 1. §97-5 (A). Tree Removal permits; Permit Required.

(3) Where a tree is proposed to be removed in conjunction with an application for development that required approval by the Planning Board or Zoning Board of Adjustment, no <u>a</u> tree removal permit under this section shall be required, but in addition to all other requirements of this Chapter, including the tree replacement requirements, which shall apply and be satisfied by the applicant as a condition of approval by the Planning or Zoning Board of Adjustment.

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

<u>Section 3.</u> If any section, paragraph, subsection, clause or provisions of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged, and the remainder of the Ordinance shall be deemed valid and effective.

Section 4. This Ordinance shall take effect upon final passage and publication as provided by law.

#### **ORDINANCE** as follows: (O-3-2019-011)

**WHEREAS**, the State of New Jersey has been engaged in a process to establish a competitive marketplace through deregulation and restructuring of the electricity supply market;

**WHEREAS**, the Government Energy Aggregation Act, <u>N.J.S.A.</u> 48:3-93.1 <u>et seq.</u>, governs the establishment of a government energy aggregation program, which is a government-operated purchasing cooperative through which multiple energy consumers purchase energy together under the auspices of a government aggregator; and

**WHEREAS**, the New Jersey Board of Public Utilities ("BPU") has adopted regulations governing the Implementation of government energy aggregation programs codified at <u>N.J.A.C.</u> 14:4-6,1 <u>et seq.</u>; and

**WHEREAS**, pursuant to the Government Energy Aggregation Act, <u>N.J.S.A.</u> 48:3-93,1 et seq., the Township of Monroe ("Township") seeks to establish a Government Energy Aggregation Program ("Program") for the provision of electricity within the Township, for the purpose of obtaining power supply cost savings for residential participants; and

**WHEREAS**, the Township Council intends to serve as the Lead Agency conducting a Government Energy Aggregation Program in the Township and, in that capacity and consistent with applicable rules, to solicit proposals and enter into a contract for the provision of electric generation services on behalf of residential and commercial customers within the boundaries of the Township, to the extent that such a contract will produce power supply cost savings to residents properties; and

**WHEREAS**, the Township Council will from time to time during the effective period as defined below solicit proposals from electric power suppliers for electric generation services through the Program in which the Township Council will act as Lead Agency of the Monroe Community Energy Aggregation ("MCEA"); and

**WHEREAS**, the Township Council will from time to time during the effective period as defined below issue one or more Request for Proposals for electric generation services and energy aggregation services on behalf of the MCEA pursuant to the Local Public Contract Law Regulations, the Government Energy Aggregation Act, and the Electric Discount and Energy Competition Act; and

**WHEREAS**, the Township Council will only award contracts for electric generation services and energy aggregation services to electric power suppliers that are deemed qualified and who submit price bids lower than the prevailing price for utility-provided basic generation service; and

**WHEREAS**, residential customers will be permitted the opportunity to opt-out of the Program and commercial customers will be required to opt-in should they determine to participate; and

**WHEREAS**, pursuant to applicable BPU regulations, the Township will enter into an Electric Distribution Company Aggregation Agreement with the local electric distribution company, Jersey Central Power and Light Company ("JCP&L"); and

WHEREAS, N.J.S.A. 48:3-93.1 et seq. requires the Program to be established by ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Township Council as follows:

1. There is hereby established a Government Energy Aggregation Program, in accordance with the provisions of the Government Energy Aggregation Act, <u>N.J.S.A.</u> 48:3-93.1 <u>et seq.</u>

2. The Mayor is authorized to execute and the Township Clerk to attest to the execution of an Electric Distribution Aggregation Agreement, in a form acceptable to the Township, with JCP&L.

3. ## **REPORTS:**

<u>Mayor's Report – Mayor Tamburro read aloud his budget message into the record:</u>

I am pleased to present a budget with no municipal tax rate increase for our residents.

This is the result of many things including our 4<sup>th</sup> year of AA+ bond rating by Standard and Poor's, our very stable surplus, and our successful collective bargaining agreements with our dedicated employees.

Most importantly, we are careful guardians of your tax dollars to provide the highest quality services in a fiscally responsible manner. This is my charge and I work each day to make sure we manage your resources wisely.

Here are some of the ways I have worked with the Council to deliver a budget with no tax increase this year.

Our largest area of savings was in employee healthcare. With costs of healthcare rising, we were able to negotiate with employees to redesign our health care program. With our changes, we saved over \$700,000 or more than 10% of our healthcare costs. Almost 30% of employees chose our new Omnia plan from Horizon BCBS, which has been well received. And, all new employees will only be enrolled in Omnia, which is a significantly lower cost. This effort was not an easy road – but it a fair solution for our employees and our taxpayers.

We have also been able to take advantage of rising interest rates and increased our interest revenue by over \$300,000.

Another factor that helps us avoid a tax increase, and this is important, is that our tax collection rate was over 99% in 2018.

In addition, our professional emergency medical services brought in more dollars than anticipated by \$300,000 and we never bill the balance after insurance to township residents. EMS responded to more than 10,000 calls in 2018.

Long term planning also allowed us to keep our tax rate flat. In 2019, our surplus is \$12 Million, a healthy level that has been consistent for many years. Additionally, our utility surplus has grown by \$700,000 this past year. These efforts help contribute to a stable tax rate and will keep us the 2<sup>nd</sup> lowest overall tax rate in the County.

Importantly, our budget success also comes from our manageable and flat debt service. Together with the Council, we have carefully managed our debt for long-term stability. I am pleased to report today that Monroe Township uses only 20% of State Department of Community affairs debt capacity. Our percentage has gone down over the past 3 years and that continued effort helps us keep your taxes low.

Regarding taxes, I want to thank our residents. Monroe is a desirable community with amazing services and terrific people. We are the safest city in Middlesex County and 3<sup>rd</sup> safest community in the state. We have the most professional police department and first responders. We have the most impressive and active library in Central Jersey. I am always excited to see our kids, teenagers, parents, and seniors using this magnificent facility.

Speaking of services, for the 28<sup>th</sup> consecutive year, there will be no increase in basic residential water & sewer rates, which are the lowest in Middlesex County and among the lowest in all of central New Jersey.

I am also proud that Monroe delivers the best value for our kids with our affordable summer recreation camp. And this year, for the first time, we have been able to expand senior programming at the senior center to nights and the weekend to serve our working seniors.

Unfortunately, for the tenth consecutive year, municipal aid remains flat with no increase from the State of New Jersey. Last year, I helped lead the fight with Assembly Speaker Craig Coughlin to reverse the cuts on the homestead tax credit for seniors and the disabled. We succeeded and our residents received \$3.3 million in 2018. I am also pleased to announce that our state school funding budget has increased \$3 Million annually since 2017. While this is not nearly what we deserve, we all fought hard, including our Board of Education, and we must continue that fight alongside our legislators.

I am pleased to learn that the County will keep their tax rate flat in 2019 as well. All of these combined efforts, will help to allow us maintain our spot as the second lowest overall effective tax rate in Middlesex County.

As I close -- let me give you a breakout of your total property tax bill. The municipal portion, which is the only portion of property taxes that are under the direct control of the Mayor & Council, is 20% of your total property taxes. The Board of Education makes up the largest portion of property taxes at 56%; the County at 18%; and the Fire Districts at 6%. For the average taxpayer, all of your municipal services **cost less than \$1,500 a year.** 

I would like to thank the Council for being a good partner and joining me in being good stewards of the public trust. I want to thank our municipal employees, who are dedicated to ensuring the excellent quality of life our residents deserve.

Finally, I want to close with the same pledge I made last year. I commit that we will continue to work together with Middlesex County, our Fire Districts, and the Board of Education for the betterment of our residents and our community. I know we will achieve more by working together and I pledge to continue that effort in 2019.

Mayor Tamburro added that the participation of our emergency services has been outstanding. There was an incident at the Regency where four women needed to be rescued after driving their car into the pond. Our police department jumped in with their uniforms to help these residents and I want to commend them for their outstanding efforts.

<u>Administrator's Report</u> – Thanked George our CFO and Lori our budget officer for all of their hard work with the budget. He stated that he appreciated the Mayor's guidance as we had no increase in taxes with no sacrifice of services which was our primary focus

One item on the agenda is an ordinance receiving 25 acres of land for our Affordable Housing Veteran's Housing Project, as well as, a resolution authorizing the RFQ process for this project.

It is a huge tribute to our Police, Emergency Services and residents that we are named one of the safest towns.

Late Friday, Mayor Tamburro received a call from Assemblyman Daniel Benson letting us know we were Awarded a \$557,000 State Municipal Aid Grant for the repair and improvements on Schoolhouse Road.

<u>Engineer's Report –</u> Engineer Rasimowicz reported that the detour plan for Perrineville Road and Prospect Plains Road has been approved at tonight's meeting. This will be a two-day project and begin once the weather breaks and have consistently warm temperatures in the evening.

New Jersey Natural Gas has been working on the restoration work to the pipeline that they installed last year.

The Daniel Ryan Concession and ADA Project is moving along great. Once the warmer temperatures come the contractor will be able to continue and finish up the work that needs to be on the outside.

We are out to bid for the 2019 Township Wide Paving Phase I which includes work being done on Centre Drive, Ericson Avenue, portions of Federal Road and portions of Union Valley Road. We anticipate to award at the May 6<sup>th</sup> meeting.

We awarded Monmouth Road paving last month which is anticipated to start later this month.

We also awarded last month Prospect Plains Road Soccer Field Concession Stand and Restrooms. The contractor has been given a notice to proceed and that project should begin next week.

# **COUNCIL REPORTS:**

# Council Vice-President Schneider –

- Attended the Library's 30<sup>th</sup> anniversary celebration today.
- Attended Maker's Fest which is very diverse. Home Depot was there helping children build things.
- Attended the Empty Bowls Project kick off breakfast. Last year there were 12 seniors in attendance and this year there were 58. In June, The Chelsea will be sponsoring homemade soups and bread served in these empty bowls. The cost to attend is \$5.00 and all proceeds are given to local food pantries. If you are unable to attend the event it is encouraged to make a donation.
- The future goal of the Senior Center building will include a refurbishment of the bocce court and shuffleboard, as well as, the shrubs and bushes.
- The Council authorized the purchase of panic buttons which is a great idea since we live in such a different world today.
- "Bonnie's Children" gather twice a month at the Senior Center, which are special needs young adults from the high school and gather there and play games, arts and crafts and have an ice cream social. The goal is to socialize these young adults.
- If you know of anyone turning 90 years old, Middlesex County will be holding their 90<sup>th</sup> birthday bash. The Township will provide two buses for those who would like to attend the event taking place in Old Bridge.

# <u>Councilman Dipierro –</u>

- The Shade Tree Commission will be distributing seedlings started on April 6<sup>th</sup>. They can be picked up at the DPW from 9:00am 11:00am, at the Library from 10:00am 3:00pm and James Monroe Park from 10:00am 12:00pm.
- April 6<sup>th</sup> starting at 12:00pm will be the kick off to Opening Day for baseball at James Monroe Park. Council President Dalina will throw out the first pitch.
- Watching our teams grow in sports and being a high school graduate here when we only had 110 to a class and now seeing our teams make it into the State Championships is very nice to see all of the recognition for what our teams do on the fields and courts. Hats off to all who participate.
- The bond referendum was defeated again. Thanks to the Clerk's Office for all of their hard work. The big question now is what is going to happen as the Board of Education and the Township is working hard to see what else can be done to make this happen.
- In regards to the water/sewer capacity test, Councilman Dipierro asked how we are doing with that report. Utilities Director Joe Stroin answered that the report is done and is in draft form. It is being reviewed and once complete it will be distributed to Council for their review. Councilman Dipierro added that another force main easement is on the agenda which he is not a fan of. The Zoning Board Meeting was moved to the Senior Center due to the overwhelming concern residents have with the water/sewer and all of the growth we have. Utilities Director Joe Stroin stated that it is the policy of the Utility Department to execute a Developer's Agreement with any new development so the residents do not bear any of the costs of infrastructure, improvement or expansion.

# Councilwoman Cohen -

- Another Commission member was appointed at tonight's meeting to the Cultural Arts Commission. The work they do is important and we have been receiving some assistance from the Senior Center. It is important for everyone to share in all of the wonderful things this Commission does.
- As the liaison to the Mayor's Youth Advisory Committee, on April 5<sup>th</sup> there will be the annual drunk driving event for the high school students, "You Save a life, you save a generation". We have worked with the Police Department and EMS to provide a valuable experience for all. The committee will also be hosting a sexual assault program.
- Very nice to see all of our sports teams receive awards for their hard work.

# <u>Council President Dalina –</u>

- Wished the Library a very Happy 30<sup>th</sup> Birthday. The Library has provided 30 years of great public service to the citizens of Monroe Township.
- On Saturday, April 13<sup>th</sup> at 12:00pm there will be an Easter Egg Hunt and Easter Bonnet Contest at the Community Center.
- Seeing the unity of the teams here earlier was truly amazing and it has been great to see them grow over the years. Years ago, we started buddy ball and now to see these children in high school and continuing in recreation and sporting events and watch their progression has been amazing.
- The Budget Workshop that was held by Council gave a good opportunity to have a discussion with the Department Heads. This was the first time seeing such a collaborative effort by all of the Department Heads for one purpose which was the residents.
- Tonight the budget was introduced and it will soon go onto the Township website for the public to review. May 6<sup>th</sup> will be the public hearing and the adoption of the budget.

## **PUBLIC:**

<u>Mark Klein, 7 Crenshaw Ct.</u> – Mr. Klein would like to congratulate the Mayor, Alan and Council for keeping the budget flat. Unfortunately, the Board of Education cannot do the same thing.

He also wanted to congratulate the Mayor for being instrumental for having the Zoning Board turn down a development. Mr. Klein asked Engineer Rasimowicz that in coming down Applegarth Road is there not a ruling as to how many units can go onto one acre because it looks disgusting and is a fire hazard; Engineer Rasimowicz responded that those applications were Gateway and Shared Properties who went before the Zoning Board when Mr. Klein was on the Board.

Mr. Klein commented that in regards to R-4-2019-092 regarding the affordable housing for the Veteran's, it is positively appreciated but he thought it was supposed to go in the area by Make-A-Wish.

Frank Stuto, 225 Fernhead Ave. - Mr. Stuto thanked the Mayor and Council for the budget.

Mr. Stuto asked if there were any plans for Tyndale and Ashmall Avenue, such as a park or recreation center there; Council President Dalina answered that it is essentially passive Open Space. Mr. Stuto stated that he lives in an area that seems to just have people hanging out and doing drugs and it would be nice to see something else there like a Community Garden. Council President Dalina stated that this is something that we can look into and advised Administrator Weinberg to get the police involved in patrolling that area.

**<u>Hy Grossman, 15 Doral Dr.</u>** – Mr. Grossman gave kudos to all the awardees tonight adding that it makes him feel extra proud to live in Monroe Township.

In regards to the school referendum it failed again even though he voted yes. He added that this tells him that our Planning and Zoning Board members need to educate themselves because when they award housing units to be developed, the consequences are rapidly growing school enrollment. He reiterated that the Council has control and the members need to be educated.

Mr. Grossman spoke about his frustration with medical marijuana being linked to recreational marijuana. They are not one in the same he stated and those that need medical marijuana for different ailments should not be punished because of those who choose to use it recreationally.

Lastly, Mr. Grossman commented that he is very proud of the library and wished for them to continue doing the great work that they do.

<u>Andy Paluri, 16 St. James St.</u> – Mr. Paluri stated that unfortunately the school referendum was defeated and last week he had an opportunity to speak with Governor Murphy and in doing so Mr. Paluri requested that he look into Monroe to give some of the school funding to.

Thanked the Council for approving to help the residents with the potential development going up in Cranbury. The residents in Stratford are very concerned with the proposed warehouse being built.

Mr. Paluri noted that Engineer Rasimowicz mentioned several traffic improvement projects that will be going on and he asked that he make sure the traffic patterns are looked at to avoid the impediment to the flow of traffic.

The Middle School will be putting on Alice in Wonderland April 6, 7 and 8. The performances start at 7:00pm. These children have worked very hard. The tickets are \$10.00 at the door and Mr. Paluri invited the Council and the community to come out and see the wonderful performance.

Lauren Dipierro, 225 Fernhead Ave. – Ms. Dipierro stated that in the Mayor's budget message she was under the impression that there was an increase to water and sewer rates last year; Administrator Weinberg stated that there was an increase for the high-end users and for those who use an extreme amount of water. Council President Dalina added that it did not really have an impact. Ms. Dipierro asked if there is a particular number that constitutes a high amount of water; Administrator Weinberg answered that he would get her that number.

**<u>Roger Meaney, 22 Harrigan Ave.</u>** – Mr. Meaney asked if there was a speculated number of units set to be built for the Veteran's Housing Project; Council President Dalina answered that there will be 37 units. Mr. Meaney asked if that counts towards our obligation; Council President Dalina answered yes.

Mr. Meaney asked about the force main going in on Docks Corner Road and stated that it would affect all of those residents living there as they are not given an opportunity to tie in. A gravity main would have been able to serve the same purpose and give residents an option so they do not have to live in the stone age.

Mr. Meaney commented that he has heard the Planning, Zoning and School board members feel there is a gap between the boards. He feels that it may be smart to get those boards together and have a brain storming meeting to see where each of the boards stand. He added that the design for the Middle School was a waste as there was no reason for the courtyard to be in the center where classrooms could have gone. He added that every 90 days these boards should get together so the needs of the community can be met.

Councilman Dipierro stated that now that the golf range has been acquired and the school referendum has been defeated twice how much more can we help. He asked if we can form a group that can help get things accomplished and can we legally do anything more to help the Board of Education. Township Attorney Schaffer responded that there is no reason as to why a councilmember could not be a liaison to the Board of Education. She added that we have taken all of the steps at this juncture to help them achieve their goals by buying the property. Administrator Weinberg stated that the Board of Education is very aware of all of the developments being built. We are under a court ordered settlement with the Mt. Laurel case. There was an extraordinary fight to lessen the impact to Monroe. That ruling forces towns to build affordable housing and developers intervene saying they are more than happy to build if the towns cannot afford to build the requirement themselves. They were trying to impose 11,600 units to be built in our Township and we were able to fight to get the number down to 850 with the 4 to 1 ratio being a total of 4,300 units. It is extremely difficult because it is mandated by the Court. We do communicate with the Board of Education with what our challenges are and we try to preserve the community the best we can. Councilman Dipierro added that he feels we went wrong when we started granting variances to developers.

<u>**Prakash Parab, 33 Dayna Dr.**</u> – Mr. Parab stated that he does not want to hear anymore lectures regarding affordable housing. There is no state law and the courts passed the judgements in favor of the builders. He stated that we have to ask the legislatures to have a fair state law. We have to lobby in Trenton. On April 29<sup>th</sup> in Princeton there will be a round table discussion and the cost to attend is \$25.00.

Congratulations to our Township in being recognized as the 12<sup>th</sup> safest in the United States.

Mr. Parab commented that he likes the fact that the budget is flat. The County is not increasing their taxes but unfortunately, the Board of Education is.

Additionally, Mr. Parab stated that when you sit on the Planning and Zoning Board the members cannot legally tell them to stop building because of overcrowding. The only way to legally stop them is by not allowing variances to be given.

Mr. Parab stated that in regards to fair funding from 2008 they owe us about \$65-\$75 million due to this. Our special education is underfunded. Lakewood went to Trenton and spoke to the State and then sued them and they received additional funding. The current funding formula takes into consideration at the age of 70  $\frac{1}{2}$  years old and this should not be included into the funding formula calculation.

Councilwoman Cohen asked if we could sue the State for fair funding for our schools or does it have to be done by the Board of Education; Township Attorney Schaffer stated that if we believe the residents are not being treated fairly by the state we can in conjunction with the Board of Education.

Councilman Baskin added his thoughts about the State's formula calculation and would like an explanation as to how they arrive at, interpret and implement that formula.

<u>**Gyaneshwar Sadamastula, 283 Morning Glory Dr.** –</u> Mr. Sadamastula stated that he is very disappointed with the defeated referendum. Being that he cannot vote it is frustrating that those who can voted such a necessity for our children down.

Mr. Sadamastula suggested that a deer-crossing sign go up on Applegarth Road near the golf range to help with deer incidents as the road is very dark. Council President Dalina stated that if it is a continuous problem then the police will recognize that and reach out accordingly to make sure a sign goes up.

Lastly, he commented that he feels a public place should be built on that side of town. It would be nice if the Council could look into more public places in that area. Council President Dalina stated that as part of the Mayor's budget we will be looking into more recreational facilities throughout the Township.

**Tom Bartley, 599 Spotswood Englishtown Rd.** – Mr. Bartley commented on the force mains going up in town. Mr. Bartley asked for the Council to not let the developers take over this town as he would like to see it continue to be good for everyone and not just the developers. He proposed that an ordinance be implemented right now that whenever possible there are no force mains as it affects all of us and it costs about \$500,000 for each one we have out there.

<u>Michael Olesky</u>, 50 Mayberry Ave. – Mr. Olesky commented in regard to the affordable housing obligation he said it has taken him about two years to understand the disconnect between the obligation and where we are with our schools. He asked how the government can help and suggested that we try and find a better way to explain it to the residents, that way the next time there is another bond referendum people will be more educated and vote yes.

<u>George Gunkelman, 5 Kelly Ct.</u> – Mr. Gunkelman commented in regards to O-3-2019-011 which deals with Energy Aggregation; he reminded Council to look into more green and renewable options.

Mr. Gunkelman asked in regards to O-4-2019-013 why we are exceeding the cap if there is no increase; Council President stated that this is done every year and Administrator Weinberg answered that there are two caps. One is an appropriation cap from 1977 which is what this ordinance is and the other is the 2% levy cap. This is the appropriation cap which 98% of the towns do. It is for good fiscal planning because you are allowed to bank the cap up to \$1.4 million should we need it. And in order to use it we need to pass an ordinance to allow us to bank. Mr. Gunkelman asked what the total amount in the fund to date; Administrator Weinberg answered that on the appropriations side we have \$1.1 million dollars from 2017, \$379,000 from 2018 and \$1.4 million from this year with the total being \$2,252,000. He offered to explain it further if needed after the meeting.

Mr. Gunkelman commented that there is a lot of talk about our affordable housing and our 4 to 1 ratio. He asked if we ever looked into the ongoing cost of what the four is. He believes that we only looked into what it would cost just for the 1. He thinks we would have been able to build it ourselves which would have benefited the school budget. Administrator Weinberg answered that the Veteran's Housing project will cost us about \$11 million dollars. The court forces you to put monies up front right now and the cost to the residents would be extraordinary. Mr. Gunkelman commented his thoughts about Administrator Weinberg's explanation.

**Robert Alfonzo, 23 Drummond Way** – Mr. Alfonzo commented that on Mounts Mills Road there is a rough patch with many potholes and with that many drivers try avoiding them by swerving into oncoming traffic. Engineer Rasimowicz answered that the roadway is in Phase 2 of the paving program. He asked who is responsible for the trees by the curb line; Engineer Rasimowicz answered that if it is not in the right of way or in an easement then it is the property owner's responsibility. Mr. Alfonzo added that his issue is that years ago, a few neighbors got together and we were told it was our responsibility to take care of the trees. We all laid out \$300. Other neighbors who did not get in on this with us went to the town and it is my understanding that the Township paid to have these trees taken down and replaced. Mr. Alfonzo wants to know why the Township paid for this for the neighbors who did not join in on having them removed initially when the neighbors who got together and split the cost to remove the trees had to pay. Administrator Weinberg stated that he would look into this.
