Councilman Dipierro had a question regarding O-6-2019-018 which accepts the deed of drainage easement from Block 68, Lot 41.28. That pipe was installed by the homeowner and then it collapsed and now we are going to take that drainage easement and repair that pipe in a separate Ordinance; Engineer Rasimowicz stated that this storm pipe drains Lower Matchaponix Avenue. It is taking water from the Township road; the pipe has been installed for decades and drains into a headwall that empties out into the stream or brook beyond this property. Councilman Dipierro stated that he watched what was put over the pipe which was from road departments who dropped off street sweepings and other types of debris. I have a problem with a resident who put in a pipe with no permits or inspections and now the Township is going to take responsibility by accepting the deed and he is afraid it is going to take more money than we are prepared to pay to rectify this issue. Council President Dalina stated it is for public service to drain the water off of

the street. Councilman Dipierro stated that the resident took on the risk of this project and added that if we are going to assume responsibility of this property we should continue using it as an open ditch instead of putting in pipes. Engineer Rasimowicz asked Councilman Dipierro when the pipe was installed; Councilman Dipierro explained that the pipe was installed by his uncle who built the home for his cousin and it was installed over years because they continued to extend it, probably around the 1990's. Engineer Rasimowicz stated that the Township has taken advantage of the pipe draining the Township roadway so the extension is less than 200 feet through this yard, the pipe is failing and some areas have collapsed and this Ordinance allows us to take control of the property and make the necessary repairs to the pipe. Councilwoman Cohen commented that her only concern is that it seems there is a professional disagreement that Councilman Dipierro is having with Engineer Rasimowicz and she would be inclined to side with the professional in this situation. Council President Dalina stated that this Ordinance was only up for introduction so there would be more time to discuss any concerns.

#### **PUBLIC:**

<u>Prakash Parab, 33 Dayna Dr.</u> -Mr. Prakash asked the amount of O-6-2019-022 and commented that these capital improvements should go into the budget. Administrator Weinberg answered that we do have a capital plan within the budget and explained that on any bond we have to put 5% down. He further explained that the capital plan is separate from the operating budget. Council President Dalina stated that this encompasses various roadway improvements, library, community center work and various improvements across the Township.

Aaron Sears, 903 Chalmers Ln.— Mr. Sears stated that he brought a complaint to the DPW and they advised me to bring it to Council. He suggested that pedestrian and bike lanes are added on Applegarth Road as he feels that there is plenty of room to do so as it is not safe for pedestrians to walk or bike on Applegarth Road, Route 33, as well as, some of the other major roadways. He commented that this would increase home values and he would be more than willing to work on this project with the Township. Engineer Rasimowicz commented that the two roads mentioned are County and State roads, as Applegarth Road is a County road and Route 33 is a State road. He added that along the new developments on those roadways, there are sidewalks being put in. He stated that he would speak with Mr. Sears further after the meeting.

UPON MOTION made by Councilwoman Cohen and seconded by Councilman Baskin, an Ordinance of which the following is the title was moved on second reading for final passage:
O-5-2019-015 BOND ORDINANCE PROVIDING FOR PEDESTRIAN AND ROADWAY IMPROVEMENTS TO SCHOOLHOUSE ROAD, BY AND IN THE TOWNSHIP OF MONROE, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY; APPROPRIATING \$820,000 THEREFOR (INCLUDING A GRANT RECEIVED OR EXPECTED TO BE RECEIVED FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION IN THE AMOUNT OF \$557,200) AND AUTHORIZING THE ISSUANCE OF \$262,800 IN BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF.

**ORDINANCE** as follows: (O-5-2019-015)

BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MONROE, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

**SECTION 1.** The improvements or purposes described in Section 3 of this bond ordinance are hereby authorized as general improvements or purposes to be undertaken by the Township of Monroe, in the County of Middlesex, State of New Jersey (the "Township"). For the said improvements or purposes stated in Section 3, there is hereby appropriated the sum of \$820,000, which sum includes a grant in the amount of \$557,200 received or expected to be received from the New Jersey Department of Transportation (the "Grant"). No down payment for said improvements or purposes is required pursuant to Section 40A:2-11(c) of the Local Bond Law, N.J.S.A. 40A:2-1 et seq. (the "Local Bond Law"), as said improvements or purposes involve projects funded by State grants.

**SECTION 2.** For the financing of said improvements or purposes described in Section 3 hereof and to meet the part of said \$820,000 appropriation not provided for by application hereunder of said Grant, negotiable bonds of the Township are hereby authorized to be issued in a principal amount not exceeding \$262,800 pursuant to and within the limitations prescribed by the Local Bond Law. In anticipation of the issuance of said bonds and to temporarily finance said improvements or purposes, negotiable notes of the Township in a principal amount not exceeding \$262,800 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

- **SECTION 3.** (a) The improvements hereby authorized and the purposes for the financing of which said bonds or notes are to be issued are for various pedestrian and roadway improvements along Schoolhouse Road in the Township, all such improvements including, but not limited to, as applicable, milling, paving, reconstruction and resurfacing of the roadways, the repairing and/or removal and installation of curbs, sidewalks, driveway aprons, retaining walls and curb ramps, guardrails, concrete improvements, site work, clearing, and roadway painting and striping.
- (b) The estimated maximum amount of bonds or notes to be issued for said improvements or purposes is \$262,800.
- (c) The estimated cost of said improvements or purposes is \$820,000, the excess thereof over the said estimated maximum amount of bonds or notes to be issued therefor is the Grant for said improvements or purposes in the amount of \$557,200.
- (d) The improvements or purposes set forth in Section 3(a) hereof shall include, but are not limited to, all engineering and design work, consulting, surveying, construction planning, preparation of plans and specifications, permits, bid documents, construction inspection and contract administration, and also shall include all work, materials, equipment, accessories, labor and appurtenances necessary therefor or incidental thereto and all in accordance with the plans and specifications therefor on file in the Office of the Clerk of the Township and available for public inspection and hereby approved.
- **SECTION 4.** Other than the Grant, in the event the United States of America, the State of New Jersey, and/or the County of Middlesex make a contribution or grant in aid to the Township, for the improvements or purposes authorized hereby and the same shall be received by the Township prior to the issuance of the bonds or notes authorized in Section 2 hereof, then the amount of such bonds or notes to be issued shall be reduced by the amount so received from the United States of America, the State of New Jersey and/or the County of Middlesex. Other than the Grant, in the event, however, that any amount so contributed or granted by the United States of America, the State of New Jersey and/or the County of Middlesex, shall be received by the Township after the issuance of the bonds or notes authorized in Section 2 hereof, then such funds shall be applied to the payment of the bonds or notes so issued and shall be used for no other purpose. This Section 4 shall not apply, however, with respect to any contribution or grant in aid received by the Township as a result of using funds from this bond ordinance as "matching local funds" to receive such contribution or grant in aid.
- **SECTION 5.** All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer of the Township, provided that no note shall mature later than one (1) year from its date or otherwise authorized by the Local Bond Law. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with the notes issued pursuant to this bond ordinance, and the signature of the Chief Financial Officer upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time in accordance with the provisions of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchaser thereof upon receipt of payment of the purchase price and accrued interest thereon from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this bond ordinance is made. Such report must include the principal amount, the description, the interest rate, and the maturity schedule of the notes so sold, the price obtained and the name of the purchaser.
- **SECTION 6.** The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

### **SECTION 7.** The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses and are improvements which the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.
- (b) The period of usefulness of said improvements or purposes within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the said bonds authorized by this bond ordinance, is fifteen (15) years.

- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the Office of the Clerk of the Township and a complete executed duplicate thereof has been filed in the Office of the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, and such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds or notes provided for in this bond ordinance by \$262,800 and the said bonds or notes authorized by this bond ordinance will be within all debt limitations prescribed by said Local Bond Law.
- (d) An aggregate amount not exceeding \$110,000 for items of expense listed in and permitted under section 20 of the Local Bond Law is included in the estimated cost indicated herein for the purposes or improvements hereinbefore described.

**SECTION 8.** The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the bonds or notes authorized by this bond ordinance. The bonds or notes shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy *ad valorem* taxes upon all the taxable property within the Township for the payment of the bonds or notes and the interest thereon without limitation as to rate or amount.

**SECTION 9.** The Township reasonably expects to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 hereof and paid prior to the issuance of any bonds or notes authorized by this bond ordinance with the proceeds of such bonds or notes. This Section 9 is intended to be and hereby is a declaration of the Township's official intent to reimburse any expenditures toward the costs of the improvements or purposes described in Section 3 hereof to be incurred and paid prior to the issuance of bonds or notes authorized herein in accordance with Treasury Regulations §1.150-2. All reimbursement allocations will occur not later than eighteen (18) months after the later of (i) the date the expenditure from a source other than any bonds or notes authorized herein is paid, or (ii) the date the improvements or purposes described in Section 3 hereof are "placed in service" (within the meaning of Treasury Regulations §1.150-2) or abandoned, but in no event more than three (3) years after the expenditure is paid.

**SECTION 10.** The Township covenants to maintain the exclusion from gross income under section 103(a) of the Internal Revenue Code of 1986, as amended, of the interest on all bonds and notes issued under this ordinance.

**SECTION 11.** The Chief Financial Officer of the Township is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Township, which are authorized herein, and to execute such disclosure document on behalf of the Township. The Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Township pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Township, which are authorized herein, and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Township fails to comply with its undertaking, the Township shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

**SECTION 12.** This bond ordinance shall take effect twenty (20) days after the first publication hereof after final adoption and approval by the Mayor, as provided by the Local Bond Law.

<u>Hy Grossman, 15 Doral Dr.</u> – Mr. Grossman asked what would happen if the grant does not come in a timely fashion; Administrator Weinberg answered that we were awarded the grant through a press release and the reason we are moving so quickly is because there was some water infiltration in an area on Schoolhouse Road by the Yeshiva. He added that we would not award the contract unless we were sure of the money and they are aware that we are moving forward. Engineer Rasimowicz added that it is also a reimbursement grant so we would lay out the money first anyways.

## **SECTION A – DEFINITIONS**

### **SECTION A – DEFINITIONS:**

- A. "UNIT" shall be defined as follows:
  - 2. Other than Residential: includes each tenant in a non-residential building, One Equivalent Dwelling Unit of potable water shall equal 185 176 gallons per day of estimated water consumption or fraction thereof. In a building with more than one tenant or occupant, each separate tenant or occupant shall be calculated separately. Example: 185 176 gal/day x 365 days = 67,525 64,240 gal/year = one unit.

### SECTION K – POTABLE WATER CONNECTION FEES AND CHARGES

- 2. The potable water connection fee for each equivalent unit shall be \$3,080.00 \$3,282.00 and the irrigation connection fee using potable water with a separate meter shall be \$1,000.00 per equivalent unit. Connection fees for single family homes not part of a real estate development are payable at the option of the applicant in two (2) installments with the initial installation paid prior to the time of the connection and the second payment due within one year. Interest shall accrue and be due to the Utility Department at 1% per month on the unpaid balance. In case the system is under construction but not yet available for connection, connection fees can be paid at the option of the applicant in two (2) installments without interest. In the case of real estate developers, the connection fees for the development shall be payable at the time of final approval.
- **SECTION 2.** All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance shall be and the same are hereby repealed.
- **SECTION 3.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

Councilman Dipierro commented he feels that the tax payers should not pay for this as he does not believe it is on the target list and it is not a parcel that makes the best sense. Engineer Rasimowicz added that the Open Space Committee voted to acquire this parcel with a 4-0 vote. The environmental restrictions on this site does have a value and that would certainly be reflected in the appraisal. He further added that the advantage is there are properties adjacent to this site and we can utilize this property to possibly get additional lots on those properties. Administrator Weinberg reiterated that this resolution is only authorizing the appraisal and we would pay the fair market value. It is 35 acres which is a large property and if this gets combined with another parcel to increase the minimum lot size it is also important to preserve. Councilman Dipierro stated that he did not ask about the appraisal he asked about the environmental. The laws for developers get harder not easier and if we take it off the tax roll we lose. If it is not buildable and it is wetlands then do not buy it. Council President Dalina added that we need to take into consideration of the Open Space Committee's vote as well.

## <u>Mayor's Report</u> – No report – absent.

Council President Dalina asked for everyone to keep Mayor Tamburro in their thoughts as his wife Carole passed away last week. This has been a very tough time for him and their family.

<u>Administrator's Report</u> – Administrator Weinberg stated that he thinks we have some of the best Township employees and Irene will be missed but we do have the best library in Central Jersey. He complimented Harold Dower and the Construction Office as they are a very professional department and it is a loss to the Township to lose his knowledge. Congratulated Susan Schwartz and added that we provide amazing services that help people within the community.

We have received the largest grant ever for the Schoolhouse Road project; thanks to the Mayor and the legislative team for making this happen.

Congratulations to Center State for receiving seven bids for the Phase II Roadway Improvement Project.

We were able to add some more safe bus stops on Applegarth Road and Joan Warren Way; thanks to Councilman Dipierro, Engineer Rasimowicz, NJDOT and our legislatures for making this happen.

We approved a shared service agreement with South Brunswick for our police department's radio equipment. We always strive to share services when possible.

In regards to the bond sale we have a mix of short and long term bonds. We are converting some of our short term bonds into long term. We only have 22% of our debt capacity and we have received a rate of 2.35%. Our short term notes were 1.52%. The bonding reflects and saves money and puts us in a good position going forward. Surplus ultimately led to the low bond rates.

The new Township website has been rolled out; it is much easier to navigate and easier to search. It makes it more transparent to be able to search for all items.

The Clean Sweep Event had over 100 volunteers; thanks to the volunteers, DPW and the Recreation Center for a great event.

Registration is opening soon for summer recreation programs. These programs are incredibly affordable and the signup deadline is June 13<sup>th</sup>. We also recruit all of our counselors from Monroe Township.

<u>Engineer's Report</u> – Engineer Rasimowicz reported that the Daniel Ryan Concession Stand and ADA project is moving along great. It is expected that the utility testing will be done next week and the project will be completed in the next few weeks.

Paving is expected next week for the Monmouth Road project.

The Prospect Plains Soccer Field Concession Stand and ADA Restroom project is moving forward.

The Phase II of the 2019 Roadway Improvements Project has been award for \$537,000. The same contractor is working on Phase I and we are looking to get that project moving along in the next few weeks.

Lastly, Middlesex County is milling and paving three roads in the Township Prospect Plains Road and Forsgate Drive, Prospect Plains Road to Half Acre Road and Butcher Road from Route 33 to North Disbrow Hill Road. The paving should be completed within the next two weeks.

- Attended two Eagle Scout ceremonies; one put a drop box at the library and the other painted a map of the United States. Congratulated the parents and the Scout Master for all of their hard work.
- The Fourth of July celebration is coming up; the event is free and held at Thompson Park. If you do attend please clean up after yourself.

### Councilman Dipierro -

- Extended condolences to the Mayor and his family for the loss of his wife Carol. Attended the viewing and funeral and it was evident the love that family has. We are all here for him and hopes the community will be as well. He is a good mayor and everyone shares in the sadness of such a sudden loss.
- The Senior Center held their first car show; there were 119 cars and trucks that participated. The people who put that together did an amazing job.
- Councilman Dipierro asked a question to Joe Stroin and Administrator Weinberg that a farmer at Dey Farm put up some fencing and is requesting free water from M.T.U.D. Joe Stroin answered that as far as the irrigation goes, we told him that we would be unable to provide that to him. Councilman Dipierro commented that he was happy to hear that as we cannot give free water. Administrator Weinberg commented that he was unsure about the fencing but would look into that tomorrow.
- Councilman Dipierro commented that there is a lot of water sitting on the newly paved Prospect Plains Road which needs to be addressed, as well as, the striping which is terrible. Engineer Rasimowicz replied that this was a County project and he did attend a meeting. CME is the engineer on this project and the striping is being addressed. The project is still bonded with the County and handicap ramps holding water will also be addressed by the contractor.
- Councilman Dipierro asked if there was an update on Monmouth Road, particularly the section by Cornell where the contractor decided to cut down trees on the Township property and dumped debris. Engineer Rasimowicz answered that the trees were removed as they were large and buckling the sidewalk. He is very pleased with the progress of the project. Councilman Dipierro added that if Engineer Rasimowicz looks at the site it is on Township property and the contractor is dumping garbage; Engineer Rasimowicz answered that there is an inspector on site and there is a staging area. This is an ongoing project and the sod will be addressed.
- Councilman Dipierro asked if there was an update about the beacons; Engineer Rasimowicz answered that we are working with the school and as part of the project we are working to get them operational.
- Councilman Dipierro stated that the railroad crossing needs to be updated and asked if Engineer Rasimowicz could take a look into this.
- Attended a school board meeting and a lot of the public is concerned with children walking to school with no sidewalks. There are no sidewalks by Woodland School and not enough room to install them. In the past they have approved these developments without sidewalks and we have to fix this. Sidewalks are very important and he believes that the Planning and Zoning level should consider this problem and not grant waivers for sidewalks.

- Asked if the Township website can stream the council meetings live; Administrator Weinberg responded that he would look into that.
- Attended the Memorial Day services; all of Council attended and it was a great honor to be a part of the team. Thanks to the Parks Department, DPW and Administration for a great job.
- Asked if signs could be posted at the Park and Rides regarding weight limits; adding that it is not hard to put up a sign as we have a sign department. Our police department can then enforce it. Administrator Weinberg responded that we can look into the park and ride as the police were not aware of any significant issue there.

## Councilman Baskin -

- He was one of the Clean Sweep volunteers and stated that one of the most disturbing things he saw was all of the non-biodegradable debris at Veteran's Park.
- Attended the chorus concert that did a tribute for the veterans which was very moving.
- Monroe Township has been recognized as Tree City USA for 2018, as well as, being environmentally conscious.

### Councilwoman Cohen -

- Reported that the Cultural Arts Commission will start their summer concert series at Thompson Park. July's concerts will include a mariachi band and a 60's rock tribute band just to name a few. In the case of inclement weather, the concerts will be moved to the Senior Center.
- Had the opportunity to see a comedian at the Senior Center on Friday evening; there were over 300 people in attendance. Next month there are over 400 people signed up to see the ABBA tribute band who will be performing.

### Council President Dalina -

- Thanked the Clerk's Office for pulling off election day as smooth as silk.
- The Seniors vs. Seniors (High School) games were a success.
- Advised everyone to cheer on their local neighborhood for the Mayor's Cup Games.
- The essence of Monroe Township is the library with the goal of the outreach program of the library being to bring the events to the public outside of the library's walls. Stated that he will make sure Council receives copies of the events included in their Friday packets.
- Wished all of the fathers out there a very Happy Father's Day.

Administrator Weinberg added that on June  $22^{nd}$  from 9:00am-12:00pm the annual fishing derby will be held at Thompson Park. This is a free event and free hotdogs will be served. Pre-registration can be done at the Community Center.

Council Vice-President Schneider added that the fishing derby is a pure delight and is happy to see it has been moved to Saturday where more people will be able to attend.

### **PUBLIC:**

Roger Meaney, 22 Harrigan Ave. – Mr. Meaney commented that there has been bonding done for the sewer, with approximately \$42,000,000 in surplus from the MTUD; he asked what the balance is and what happens when it is depleted. Administrator Weinberg answered that it was actually \$36,000,000 and explained that in 2010 there was an influx of tax appeals and they were able to use that money to not raise taxes. The utility does not need money from the Township, adding that we did a pretty good job at weathering the storm as some municipalities bonded for the tax appeals happening at that time.

Mr. Meaney commented that in regards to the parking lot that Councilman Dipierro is speaking of, being in the trucking industry he knows that people go there to sleep.

<u>Prakash Parab, 33 Dayna Dr.</u> – Mr. Parab extended his deepest condolences to the Mayor for the loss of Carole.

Mr. Parab gave an overview of two bills that are going before the legislature and stated that we should begin to be the lobbyists in getting these bills passed, as they are for shared services, school funding and special education services.

Council Vice-President Schneider commented that she is aware of the problems with Special Education services and asked if Mr. Parab has brought this to light to the Board of Education.

Hy Grossman, 15 Doral Dr. – Mr. Grossman extended his condolences to the Mayor.

Attended the Board of Education meeting the other night where over 200 parents attended to voice their concerns over the bus service being taken away. He stated that when the community bands together and attends meetings things can change.

The library is his favorite place in town, adding that his wife reads 4-5 books per week. Tomorrow the bookmobile will be at the Regency and when his wife was handicapped, they came to their home and delivered books to her.

Mr. Grossman gave an analogy of the Municipal budget/Debt vs. personal income/home mortgage. He then stated that you leverage your income to build the community and in regards to the latest bond issue he asked if it was a fixed rate. Administrator Weinberg commented that there are a few different rates but the overall interest rate is 2.35%.

Kumar Thirumalaiappan, 32 Sheller Dr. — Attended the Board of Education meeting and asked if it would be possible for the Township to help the Board of Education with bus funding; he also asked if the Township could buy buses or borrow buses from the Senior Center for the morning. Administrator Weinberg answered that there are different bus safety regulations when it comes to children, adding that we do work closely with the Board of Education and if they had a need, they would reach out to us.

Mr. Thirumalaiappan commented that the summer program for the children was always 7 weeks and now it is only for 1 month; Administrator Weinberg stated that the summer program was always for 5 weeks with an aftercare program that ran for longer which was handled through a 3<sup>rd</sup> party provider. There were no cuts in the Township program.

Mr. Thirumalaiappan asked if there could be an additional push in getting the County to extend Applegarth Road into two lanes. Engineer Rasimowicz stated that the County once did wish to make Applegarth Road 2 lanes. The big-ticket item would be property acquisition but he will inquire as to where they stand with that.

Michelle Arminio, 9 Nathaniel St. – Mrs. Arminio extended her condolences to the Mayor.

She thanked Councilman Dipierro for going around town and looking at areas that need consideration, adding that she is grateful for when he gives his report because it is not just about the fun activities around town or the events he has attended but it is also about the things that need to be addressed. Someone once said that it takes leadership to bring up the things that need attention. Mrs. Arminio shared that she has lived here since 1980 and it is no longer farmland due to the development. With waivers of sidewalks and so on and so forth the Planning and Zoning Boards are inconsistent with their response to the developers. She thanked Councilman Dipierro for recognizing that.

Mrs. Arminio stated that she believes Schoolhouse Road has been repaved about 5 times, whereas Nathaniel Street has huge cracks in the road. She added that it does not seem like good use of taxpayer monies to keep repaving the same roads over such short periods of time.

In regards to R-6-2019-157 and R-6-2019-168 she asked what services Center state will be providing for \$95,000 and asked if there was a 3<sup>rd</sup> party involved as well; Administrator Weinberg answered that this is for the design and bid for the project. 13% of the hard cost of the project which was very reasonable, if not a low number. Administrator Weinberg followed that R-6-2019-168 is for a survey and environmental study and it is detailed within the contract that they can sub it out. Center State will be overseeing it all.

Mrs. Arminio commented that there were many polling locations, including the library, that did not have "Vote Here" signs posted.

Mrs. Arminio asked if we can request the County to reduce the speed limit on Applegarth Road; Engineer Rasimowicz answered that he believes the speed limit has been reduced to 35mph.

Mrs, Arminio asked if it can also be requested a left hand turn be placed at Oaktree School.

Lastly, she asked in regards to O-6-2019-022 what the improvements would be; Council President Dalina responded.

<u>George Gunkelman, 5 Kelly Ct.</u> – Mr. Gunkelman commented that he thought that Schoolhouse Road was a County road and asked why instead of the County paving this we are receiving a grant from the State to pave it; Engineer Rasimowicz answered that Schoolhouse Road is a Township Road not a County Road.

**UPON MOTION** made by Councilwoman Cohen and seconded by Council Vice-President Schneider the Combined Agenda/Regular Meeting was Adjourned at 8:36pm.
