Council President Cohen introduced Chief Biennas who explained that the Monroe Township Police Department is implementing a new program to help people with autism spectrum disorder during a traffic stop called the Blue Envelope Program. This program was introduced to the Police Department by a resident who inquired if this was something we could consider implementing. He went on to explain that Sergeant Silvestri did the research and with the support of the community and fellow officers he hopes this will be a successful program. Sergeant Silvestri came up and gave an overview of the program explaining that this will help facilitate better communication between the driver and officer as the "Blue Envelope" keeps all important driver documentation in one safe place to give to the officer in the event of being pulled over and on the flip side of the envelope explains what the driver's issues are, ie. non-verbal or verbal. Sergeant Silvestri went on to say that this program is a positive one for the Township and invited anyone who is interested for either themselves, a friend or family member to contact the Police Department to set up an appointment to come in and receive a "Blue Envelope" and have an explanation of the program given to them. Chief Biennas added that Governor Murphy recently passed a law to allow a designation made on the license plates of those with autism spectrum disorder and this program will help compliment that.

Mayor Dalina alongside Councilwoman Siegel gave an overview of the Mayor's Youth Advisory Committee, which started approximately six years ago by former mayor Gerald Tamburro. He went on to share that the Mayor's Youth Advisory Committee has embarked on many learning ventures, such as learning about municipal government and Robert's Rules of Order and meeting with various Department Heads of the Township to learn about their responsibilities within the Township. He went on to talk about the mock DUI crash and trial that the Mayor's Youth Advisory Committee held that took place at the high

school to educate everyone on the dangers and reality of drunk driving. He went on to say that the members of this Committee have shown such enthusiastic interest in what we all love within the Township and extended congratulations for all their hard work.

Councilwoman Siegel shared that the Mayor's Youth Advisory Committee is open to all MTHS students who are then invited to apply and submit a resume for consideration to be apart of the Committee. After careful consideration 20 students were picked to be a part of the Committee who then met once a month to learn about municipal government, as well as the Police, EMS and Clerk's departments. She went on to say that they also learned about mental health, engaging with seniors, and spent time presenting a project to the Mayor and Council as well. Mrs. Arminio asked if surplus is kept as surplus; Administrator Weinberg and CFO Lange explained.

Mrs. Arminio asked if there were any judgements against the Township; Administrator Weinberg answered that there are no judgements.

Administrator's Report – Before giving his report, Administrator Weinberg invited Director Stroin up to give an update on the BFI project; Director Stroin stated that the pump station is complete with the exception of the control panel. He added that the control panel has shipped and will take approximately 1 week to install, therefore he is confident that this will be completed before school lets out.

Administrator Weinberg reported that a preconstruction meeting has been held for the 2023 Roadway Improvement Project.

The DPW yard, softball complex and Construction parking lot upgrades have been completed and look beautiful. He extended thanks to Engineer Rasimowicz for all his hard work and involvement in this project.

The Senior Center will have a ribbon cutting for their new outdoor pavilion which will allow for more activities to be held outside.

Engineer's Report – Engineer Rasimowicz reported that the demolition on Mounts Mills Road has been completed and the demolition on Docks Corner Road is nearing completion.

The ADA restrooms at Veterans Park are near completion, we are still awaiting materials to finish.

The 2023 Roadway Improvement Project is set to begin in July/August. This project encompasses 16 roadways and includes the municipal, police and EMS lots.

The Spotswood Gravel Hill Road Roadway Improvement Project has been sent to the NJDEP for approval and it is his hope that it will be awarded at the next Council meeting.

Council President Cohen added that she toured the newly improved DPW yard and saw the new foam machine which is a game changer for the Township's recycling process. She added that the yard is nice, clean and bright with employees who truly enjoy being there.

Council's Reports -

Councilman Dipierro -

- Asked for an update on the Prospect Plains/Applegarth Road project; Engineer Rasimowicz responded that this is a County sponsored project with the Township in the process of acquiring the land. Councilman Dipierro asked if there was an idea of when this would be ready to which Engineer Rasimowicz answered that it all depended on how long it takes to acquire the various land necessary for the project to move forward.
- Commented that the Old Bridge/Mounts Mills Road project seems to have taken years and with R3M handling the water conflict he asked if there was an update; Engineer Rasimowicz stated that this is a County project which they bid and plan to award at the next County meeting. He added that he does not have time of completion but will be meeting shortly for a preconstruction meeting and will report back once he finds out. Councilman Dipierro stated that he would like to attend the preconstruction meeting to which Attorney Rainone answered that the County does not allow members of Council or the public to attend those meetings as the attendance is strictly meant for the professionals.
- Noted that June 1st through the 7th is First Aid Awareness Week and extended thanks to all the First Responders for the work that they do to help us.
- Commented that the new foam machine at the DPW will be very beneficial to the Township. He added that the employees are dedicated and appreciative and they have made the DPW what it is today. He noted that the contractor, DPW and Center State did a phenomenal job completing that project as it looks beautiful.
- Extended thanks to the Finance Department for their work on the budget as he met with them to have his questions answered noting that it is a budget that makes sense and makes everyone aware of our reality.
- Thanked the Clerk's Office for their hard work during election season.
- Reported that the County would remill and repave Spotswood Englishtown Road to take care of the standing water and waviness of the paving and was wondering if there were any updates about the status of that; Engineer Rasimowicz commented that there is no schedule for them to come back. Councilman Dipierro stated that in going forward we should have our inspectors go over their

work and put the County on notice for work that they have done that is not up to par. He added that during the last project they were in charge of, there were M.T.U.D. valves that were paved over and paving done during the cold, which ends with results that were not what was expected.

- Attended the Memorial Day ceremony at Veteran's Park, commenting that there was a nice turnout with everyone paying their respects to those who put their lives on the line for our freedom.
- Thanked Director Stroin and his staff for the hydrant flushing.
- As liaison for the Shade Tree Committee, he noted that Arbor Day was yesterday and was invited to attend an event at Oak Tree School that was organized and educational. Thanked Pam Broskie and the Administration at Oak Tree for putting it together.
- Shared that May 25th holds significance to him as not only is it Armed Forces Day but he lost his dad 28 years ago on that day as well. He shared that he attended the Armed Forces Day ceremonies held at the high school which were very touching and nicely done.
- Wished all the father's a very Happy Father's Day.

Engineer Rasimowicz added that the Spotswood Englishtown Road project noted in Councilman Dipierro's report had an equipment malfunction and he is working with the County to have that, as well as various other issues addressed.

Councilman Markel -

- Reported that his first month on the Council has been interesting as he attended a plethora of events and extended thanks to the Administration for keeping him going.
- As liaison to the Commission on Aging and Open Space he has learned a lot so far including that thousands of residents walk through the Senior Center building to attend activities and events there. He also shared that our transportation services help transport thousands of residents each month. He advised those looking to register at the Senior Center to come earlier in the day. Regarding Open Space, he noted that the Committee analyzes where to put Open Space within the Township which includes things like wetlands, horse trails and passive recreation.
- Attended Interfaith Prayer Day, Om 5K Walk/Run, Indian Culture Day at Barclay Brook School, Armed Forces Day and the Memorial Day ceremonies.

<u>Councilwoman Siegel</u> –

- Commended the Mayor, Finance Department and Administration on the budget as it is very comprehensive and responsible.
- Visited the DPW and saw the foam machine which is a game changer for the Township's recycling operations.
- Commented that the Senior Center pavilion is beautiful and allows for more outdoor activities to take place.
- Attended the 11th Annual Indian Culture Heritage Day which is always a fun and educational event that highlights the beauty and diversity within the Indian culture.
- Attended the Memorial Day ceremonies which had a nice turnout and honored those who paid the ultimate sacrifice for our freedoms.
- Attended the Oak Tree School Arbor Day Celebration which was very educational, noting that the Kindergarteners and 3rd graders were so knowledgeable.
- The Cultural Arts Commission will host a 1970's rock show at the Performing Arts Center on June 4th. Also, the Summer Concert Series will be returning in July for the concerts in the park.
- The Historic Preservation Committee will have a guest speaker on June 4th from 1-4pm. They also have put together an exhibit honoring the Veteran's which she invited all to come out and see.

<u>Council Vice-President Van Dzura</u> –

- Attended the Armed Forces Day ceremonies at the high school, noting that this event involved all to show and tell what they have been through which was eye opening.
- Attended the Memorial Day ceremonies to honor those who paid the ultimate sacrifice for our freedoms.
- Noted that the War in Ukraine has been going on for 1-1/2 years now.
- Toured the DPW yard, commenting that it looks fantastic.
- Excited to see the implementation of the Blue Envelope Program as getting pulled over is nerve wracking for anyone and even more so for those who have autism spectrum disorder.
- Attended the Indian Heritage Day event at Barclay Brook School which was very educational.
- Shared that the high school's lacrosse team has won their 5th straight GMC title.
- The Recreation Advisory Committee has announced that there is now a cricket club.
- Complimented the Administration and Finance Department for their hard work on the budget.
- Noted that Sean Dowling is no longer the Athletic Director of the high school and wished him well on his future endeavors as he will be missed.

Mayor's Report – Mayor Dalina commented that in addition to Memorial Day being held in May, it is also Military Appreciation Month. He shared that he watched a movie called "Devotion" which is based off a true story about the Navy's first black pilot, Jesse Brown and his wingman Tom Hudner who fought in the Korean War. He added that this movie encompasses heroism, friendship and sacrifice and recommended all to watch it.

Commented on the budget, stating that it is a process that is continuously ongoing and extended thanks to the Administration, Council, and citizens of the Township. He asked for patience while we await the DCA to review and sign off on it.

Shared that he toured the newly paved DPW yard, commenting that it is not only clean but less intimidating to the residents utilizing it.

Received \$118,000 in Clean Communities grant money which is exciting. Also shared that the Township has applied and received \$76,000 in grant monies for two volleyball courts which will be placed at Veteran's Park.

Thanked Bill, Kim and Matthew for bringing the Blue Envelope Program to the attention of the Police Department; also extended thanks to Chief Biennas and his department for their due diligence in getting this important program implemented.

Reported that we are partnering up with the County's Surrogate's Office to have the County Surrogate at the Library providing their services for wills, probates, and trusts.

Excited to share that the Monroe Senior Softball League kicked off their season and invited all to come out and watch them play.

The Fishing Derby will be held on June 10th and the Spray Park is officially open for the summer season.

Our Library will once again host a Farmer's Market which is set to begin on June 22nd and run through September 14th.

The Mayor's Wellness Commission will embark on a lesson in Tai-Chi which is set for June 3rd at 10:30am at Veteran's Park. Mayor Dalina also shared that he participated in the TD Five Boro Bike Tour on May 7th where he biked 40 miles.

Noting that tomorrow is June 1st, Mayor Dalina encouraged everyone to get out and enjoy the weather and lastly wished all the father's a Happy Father's Day.

Public Comments –

Beth Dipierro, 404 Spotswood-Gravel Hill Rd. – Mrs. Dipierro reported that Verizon users are not receiving the Monroe channels and when inquiring as to what the problem was she was told that it is a Township issue with the Verizon hookup at the high school; Administrator Weinberg responded that the server is no longer functioning, and we are currently partnering with the school to purchase a new server. With that being said, this will take a bit of time so in the meantime all information can be accessed on Township's YouTube channel and will also be placed on the Township's website.

<u>Michele Arminio, 9 Nathaniel St.</u> – Mrs. Arminio asked in regard to the NJDOT grant what roadway will that cover; Engineer Rasimowicz answered that this will cover Spotswood Gravel Hill Road to Avenue K and Matchaponix Avenue.

Mrs. Arminio asked for clarification on R-5-2023-165, which is the professional services contract with R3M, and asked why the water main is being relocated; Engineer Rasimowicz answered that this is part of the intersection improvement project with the County, and we are responsible for relocating.

Mrs. Arminio asked if there is a fee to join the coop regarding R-5-2023-166; Administrator Weinberg answered that we contract every year for employee uniforms and cleaning services and joining this coop gives us the best pricing to provide that service.

Thanked the Mayor and Council for the work at the DPW yard and for the foam recycling machine.

<u>Harold Kane, 480B Newport Way</u> – Mr. Kane stated that he wanted to pick Engineer Rasimowicz's brain regarding the issue with Prospect Plains Road stating that years ago there was a proposal to widen that roadway from the Cranbury line with Phase I beginning on Applegarth Road and asked if this was ever approved and if there were any updates; Engineer Rasimowicz answered that the proposal was discussed 20+ years ago where it was talked to widen the roadway to five lanes but currently the proposal is to widen it to three lanes with no proposal for the Rossmoor culvert crossing to be widened as it was done already.
