Mr. Bartley asked for the Council's stance on the Israel and Palestine war; Council President Cohen stated that we are all free to follow the dictates of our own conscious and Mr. Bartley's question as to whether or not we are for or against the backing of Israel does not fall within our purview to discuss.

<u>Rebecca Zinnikas</u>, 431 Hobart Rd. North Brunswick – Ms. Zinnikas stated that she was coming before our Mayor and Council in her capacity as a registered nurse for RWJ Hospital in New Brunswick to discuss the impact the current strike has had on the nursing staff and patients. She went on to explain that the strike began on August 4th with the main goal being to achieve safe staffing as the more patients registered nurses take on the mortality rates increase. She went on to explain that legislation has stalled for 20 years on passing bills S304 and A4536 which address the need for safe staffing ratios and she, along with other registered nurses are seeking support for these bills from each legislative district by asking that resolutions are passed in support.

<u>Alan Gould, 518B Hazen Rd.</u> – Mr. Gould stated that he is a resident of Monroe Township for over 12 years and he is here advocating for the nurses for safe staffing ratios. He stated that he has experienced from both sides the importance of having enough nursing staff as they are on the front lines. Mr. Gould presented handouts along with a sample resolution for the Council's consideration.

Margaret Andersen, 5 Ralston Way – Ms. Andersen stated that she has been a registered nurse with Robert Wood Johnson for over 39 years and it has been 97 days since the strike began. She went on to explain that the nurses are fighting for fair and safe staffing to help care for their patients along with their own mental health. Ms. Andersen explained that it is very important to have legislation passed in support as the impact of not having enough registered nurses increases the mortality rate by 12% for every additional patient that is added to their care. Ms. Andersen shared some statistics in support of passing the safe staffing bills. Council President Cohen asked where statistical data was pulled from to which Ms. Andersen stated the National State Board of Nursing.

<u>Pat Schwalje</u>, 586A Madison Dr. – Ms. Schwalje shared that she was a patient at Robert Wood Johnson in April and her heart breaks for the registered nurses undertaking of additional patients as she has noticed that the hospital feels like a business now.

Ms. Schwalje commented that as a child of a WWII veteran she was furious that our former president did not attend the 75th anniversary of the Invasion of Normandy. She went on to thank Mayor Dalina for his support of veterans.

Ms. Schwalje suggested to Councilman Dipierro that he read the recent freight studies for any updates he is looking for.

Thanked the residents of Monroe for supporting Team Dalina as she is tired of the rhetoric.

<u>Brian Fabiano, 19 Patricia Pl. – Mr. Fabiano quoted Michelle Obama's famous line, "when they go low, we go high", which he feels summarizes what has transpired these last few months. He went on to say that pushing lies and falsa propaganda is shameful and congratulation all for their overwhelming reelection win as they worked hard and held a clean campaign.</u>

Extended thanks to the Clerk's Office for all their hard work, along with Director Stroin, Engineer Rasimowicz and Chief Biennas who are all hard working and respectable employees.

Mr. Fabiano went on to say that the things that will remain are Veteran's housing, safe communities, Board of Education issues, Recreation programs and it is disappointing to have to explain to children how dirty things can get when you can instead lead with honesty.

Beth Dipierro, 404 Spotswood-Gravel Hill Rd. – Mrs. Dipierro congratulated all on their reelection and stated that we will remain with heads held high as they have nothing but respect for all here in Monroe Township. She stated that no lies were told, no dirty work and she is proud of the Dems for not playing dirty as we should all be here to help and listen to each other's ideas.

<u>Catherine Hunt, 121P Lowell Ln.</u> – Ms. Hunt stated that she was here in support of the nurses and hopes Council will pass a resolution in support of safe staffing.

Extended congratulations to all on their reelection.

Councilman Dipierro asked what the next step to support the registered nurses would be; Council President Cohen stated that our attorney has all of the information provided and will advise us as to what the next step would be. She added that she has also been in touch with the nursing director of Rutgers for additional information as well. Councilman Dipierro asked if this could be expedited to which Council President Cohen responded that once our due diligence was done then we proceed with the next steps.

UPON MOTION made by Councilman Dipierro and seconded by Councilwoman Siegel, the **PUBLIC COMMENTS** portion of the Meeting was closed. All were in favor, none opposed.

UPON MOTION made by Councilman Dipierro and seconded by Councilwoman Siegel, the Regular Meeting was Adjourned at 7:30pm.
