ORDINANCE OF THE MONROE TOWNSHIP COUNCIL  
AMENDING CHAPTER 38A OF THE CODE OF THE TOWNSHIP OF MONROE  
ENTITLED, "FACILITIES POLICIES AND PROCEDURES"

**BE IT ORDAINED** by the Council of the Township of Monroe, County of Middlesex, State of New Jersey as follows:

**SECTION 1.** Chapter 38A of the code of the Township of Monroe is hereby amended to add §38A-3. "Bulletin Board Policy" as follows: (new text is in red and underlined)

**Chapter 38A FACILITIES POLICIES AND PROCEDURES**

**§38A-3. Bulletin Board Policy.**

The bulletin boards located in the Township Municipal Building and other Township owned facilities are only intended for official notices regarding Monroe Township and/or other Township entities (ie: Fire Districts, Board of Education etc.) policies, procedures, meetings and special events. Only authorized personnel may post, remove or alter any notice.

**SECTION 2.** All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance shall be and the same are hereby repealed.

**SECTION 3.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 4.** This Ordinance shall take effect upon final passage and publication as provided by law.

**SO ORDAINED**, as aforesaid.


