**ORDINANCE OF THE MONROE TOWNSHIP COUNCIL  
AMENDING CHAPTER 122 OF THE CODE OF THE TOWNSHIP OF MONROE  
ENTITLED, “VEHICLES AND TRAFFIC”, SPECIFICALLY  
SECTION 122-30 ENTITLED “NO PARKING”**

**BE IT ORDAINED** by the Township Council of the Township of Monroe, in the County of Middlesex, New Jersey as follows:

In accordance with the provisions of § 122-06, “Parking prohibited at all times”.

**SECTION 1.** Section § 122-30, Schedule I entitled “No Parking” in accordance with the provisions of § 122-06, the following are hereby amended as follows: (additions in blue, deletions in red)

<u>Name of Street</u>	<u>Sides</u>	<u>Location</u>
<del>Buckelew Avenue</del>	<del>South</del>	<del>From a point 330 feet from the easterly curblineline of Frederick Street to a point 195 feet easterly therefrom.</del>
<del>Buckelew Avenue (CR 522) Zone 1</del>	<del>East</del>	<del>From Schoolhouse Road to the Driveway of Brookside School.</del>
<del>Buckelew Avenue (CR 522) Zone 2</del>	<del>East</del>	<del>From Little Brook Lane to State Street</del>
Buckelew Avenue (CR 522)	Both	From the Monroe Twp. – Jamesburg corporate border to the Monroe Twp. – Manalapan corporate border.
Cranbury- Half Acre Road	Both	Entire Length
Cranbury Station Road	Both	From the intersection of Applegarth Road (CR 619) to the Monroe Twp. – Cranbury Twp. corporate border.
Hoffman Station Road	Both	From intersection of Buckelew Avenue (CR 522) to 900’ west of the Intersection
Union Valley–Half Acre Road	Both	From the intersection of Prospect Plains Road (CR 614) to Applegarth Road (CR 619)

**SECTION 5.** All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed to the extent of such inconsistency.

**SECTION 6.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 7.** This Ordinance shall take effect twenty days after final passage, adoption and publication according to law.
