ORDINANCE OF THE MONROE TOWNSHIP COUNCIL AMENDING CHAPTER 116 OF THE CODE OF THE TOWNSHIP OF MONROE ENTITLED, "TOWING AND STORING OF VEHICLES"

BE IT ORDAINED by the Council of the Township of Monroe, County of Middlesex, State of New Jersey that Chapter 116 of the Code of the Township of Monroe is hereby amended as follows: (new text is in red and <u>underlined</u>, text to be deleted is struck)

Chapter 116 Towing and Storing of Vehicles

§ 116-6. Application fee. [Amended 6-5-02 by Ord. No. 0-6-2002-029]

Each applicant for a permit must submit an application fee in the amount of one hundred dollars (\$100.) with the application. The fee shall be applied to costs incurred by the township in processing the application and for the inspecting of the tow vehicle(s) and equipment contained therein.

<u>The fees for "Application fee" for the Towing and Storing of Vehicles shall be in accordance with Chapter 39-3B.18 of the Code entitled "General Fees."</u>

SECTION 2. All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance shall be and the same are hereby repealed.

SECTION 3. If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

SECTION 4. This Ordinance shall take effect upon final passage and publication as provided by law.
