Mrs. Arminio asked in regard to O-9-2023-024 if this was an eminent domain purchase to which Attorney Gordon answered that this was a voluntary conveyance for roadway improvements. Engineer Rasimowicz added that this is a single-family home which received approval with the right of way being apart of that approval.

<u>Lucille Panos, 1208C Lindera Plz.</u> — Mrs. Panos asked in regard to R-10-2023-236 if there were other bids considered for this project as it was only awarded a month ago and already has a \$52,000+ change order being considered. Administrator Weinberg responded that this was done as part of the Bergen County Coop. and our Construction Department came in and advised that fireproof wood and an H panel would be needed, which in turn essentially changed the scope of the project, which is why there is an increase to compensate for those items deemed necessary. Mrs. Panos stated that it is a shame to move forward with this and feels it should be reconsidered. Administrator Weinberg stated that our DPW did the original scope and our Construction Department found safety issues due to the specs of our building and we must keep to code.

THE TOWNSHIP OF MONROE ENTITLED "TOWING AND

BE IT ORDAINED by the Township Council of the Township of Monroe, County of Middlesex, State of New Jersey that Chapter 116 of the Monroe Township Code entitled "Towing and Storing of Vehicles" be amended and supplemented as follows (new text is in red and underlined, text to be deleted is struck):

§ 116-4. **Application for permit.**

D. The required documents set forth in Section 116-5, 116-6, and 116-9 of this chapter shall be submitted annually and/or upon expiration to the Township Clerk and whenever there is a deviation from the original application in regard to change of location, change of personnel and/or change in vehicles.

Application review. § 116-7.

(6) The applicant owns or has a valid lease to a storage facility within the Township boundaries within 5 miles of the Township boundaries, in an area legally zoned for such use, and such storage facility includes a minimum of 10 outside spaces and an inside secured facility for storage of impounded vehicles.

§ 116-12. Performance standards.

Maintenance of place of business. Light and medium duty tow operators Α. shall maintain a principal place of operation within the township within 5 miles of the Township boundaries, as a property tax payer or holder of a valid lease. A heavy duty tow operator shall maintain a principal place of operation within fifteen (15) miles of the township boundaries. Tow

operators shall comply fully with all of the zoning, land use and property maintenance codes of the township in which the tow operator's business is located.

- (1) Each place of business will provide and maintain the following:
 - (a) One (1) tow operator allowed per base of service or storage facility. Those existing operators who lease and share storage facilities with another tow operator, at the time this section is enacted, shall have one (1) calendar year from the date of enactment to comply with this requirement.
 - (b) (a) A store front including signage displaying the business name, address and phone number.
 - (c) (b) A person in the office to greet customers rendering service.
 - (d) (e) A waiting area for patrons' use.
 - (e) (d) A properly maintained and working restroom for patrons.
- **SECTION 2.** All ordinances or parts of ordinances inconsistent with the provisions of this ordinance shall be and the same are hereby repealed.
- **SECTION 3.** If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.
- **SECTION 4.** This ordinance shall take effect twenty days after final passage, adoption and publication as provided by law.

Working on a future shared partnership with the Board of Education to take advantage of a \$4 million dollar State ROD Grant and a \$1 million dollar State budget grant both of which are specifically for Applegarth School improvements. He went on to share that Mayor Dalina wants to take advantage of State funding, keeping that money in Monroe to benefit our children and will share more details once available.

Highlighted the shared services agreement with Fire District #2 on tonight's agenda; as Mayor Dalina is a huge proponent of shared services and this will help us accomplish more for the taxpayers.

Thankful to see another State OEM grant received in the amount of \$10,000 for OEM training and technology purposes.

Extended thanks to the DPW, OEM and MTUD for their hard work in preparing the Township during the recent storms we have had.

Shared that the Library is making some exciting improvements to their front desk area which will provide a more open experience once finished. It is expected to take approximately two months to complete and it is asked to pardon their appearance when entering inside. It was also noted that they processed over 402,000 transactions last year which was 10% more than previous years.

Reported that the Township has the second lowest tax rate in the County and has an AA+ bond rating which is positive for our community when refinancing our debts.

County wide shredding events will take place on Saturday, October 14th at the Cranbury School between 9am-12pm and then again on November 3rd at Thompson Park

A Veteran's Day recognition ceremony will be held on Saturday, November 11th at Veteran's Park on Avenue K, as well as, a celebration luncheon to be held at the Senior Center on November 5th beginning at noon. Mayor Dalina was also invited to attend a veteran's recognition service at the Regency on November 10th and at Clearbrook on November 11th.

Councilman Dipierro stated that he appreciates Administrator Weinberg following up as many of our clubs receive grant money for participating in the Community Clean Ups to which Administrator Weinberg commented that those clubs have been helping with the other ongoing cleanups as well.
- Inquired as to what the status with replacing the server at the high school was so we can get our channel available again to our residents; Administrator Weinberg answered that Mayor Dalina has had a conversation with the Board of Education President explaining that the Township would like to help with the situation so the terms are being worked out and will be included in the shared services agreement.
- Inquired as to whether or not we have completed the hydrant flushing project; Director Stroin answered yes.
- Noted that the barn located on the corner of Mounts Mills Road and Buckelew Avenue needs to be winterized as there are boards flying around that need to be secured.
- Inquired as to whether or not we are getting the deed for the old police department property; Administrator Weinberg responded that we have been working with the Department of Treasury explaining that this is the 93 acres across the street from the boy's home which contained "Camp Derek" and we have been able to get those 93 acres turned into Green Acres and hopes on planning to announce within the next month which will be a positive development for the Township. Councilman Dipierro asked if the dead trees near the roadway in that area can get addressed.
- Reminded everyone to support our local businesses by shopping locally as it is very important to try and keep these businesses afloat.
- With Halloween coming, reminded everyone to drive safely.
- Lastly, sending prayers to Mayor Dalina and his family.

<u>Council Vice-President Van Dzura –</u>

- Attended the Green Fair, which was a very informative event and extended thanks and appreciation to all who worked hard to get this event up and running. Council Vice-President Van Dzura went on to share that there was a stand there promoting organ donation which is something that everyone should consider, as it is as easy as having it noted on your driver's license so in the event you pass away your organs can be donated to help save someone else's life.
- Announced that the Veteran's Day celebration will be help on November 5th from 12pm-2pm at the Senior Center which is something very near and dear to Mayor Dalina as he always does a great job with showing appreciation for our Veteran's.
- Noted that as we pass September 11th it is important to show appreciation to our Police, First Responders, EMS and all who go out onto the scene as well as the nurses, who during Covid were on the frontlines dealing with a pandemic that not only put them at risk, but some even lost their lives. Currently, the nurses at Robert Wood Johnson are on strike looking for better working conditions, as without it their work conditions are adversely affected, which in turn may affect you or someone you know needing care; therefore, it is important to read up on what is going on and support their fight.
- Reminded all that the Ukrainian War continues to go on and has been going on for so long that it seems like secondhand news. He went on to note that the last budget approval did not have any money appropriated to help Ukraine and he would urge our federal officials to continue to support these people as if Ukraine falls to Russia it would create a domino effect that would not be good.
- Wished everyone a safe and happy Halloween.

Council President Cohen -

• Invited all to come trick-or-treating at the municipal building on Halloween with more information available on the Township website for all who may be interested.

<u>Mayor's Report</u> – No Report; Absent. Business Administrator Weinberg gave Mayor's comments during his report.

UPON MOTION made by Councilwoman Siegel and seconded by Council Vice-President Van Dzura, the **PUBLIC COMMENTS** portion of the Meeting was opened. All were in favor, none opposed.

Public Comments –

Naomi Holzer, 453 Bluebird Dr. – Ms. Holzer stated that she is a retired first responder and former registered nurse who has put her life on the line for others but feels that her contribution to society is paltry compared to what our Veteran's sacrifice in defending us and this country. Ms. Holzer went on to share that her father was a veteran, and she feels that Mayor Dalina attending the various veteran's celebrations alone is appalling as she does not understand why no one else attends. Council President Cohen rebutted asking where she heard that only the Mayor attends these events as they have all attended various veteran's ceremonies throughout the Township. Administrator Weinberg clarified that any Township events are always open to the Mayor and Council but private organizations holding various events who may only invite the Mayor and/or the Council to attend and exclude the public which the Township cannot control. He also explained that Mayor Dalina created a Veteran's Committee two years ago where there are even more events happening around the Township. Ms. Holzer commented that there should be more than just the Mayor's presence at the events held throughout the Township, to which Administrator Weinberg reiterated that the Township cannot control who is invited to events being held by private organizations or private communities with Attorney Gordon affirming the same.

Joellen Arrabito, 22-O Rossmoor Dr. – Ms. Arrabito stated that she hears comments being made about Ukraine and asking for support for what is happening over there but is curious if anyone has any comments on the nonsupport of the invasion of our southern borders; Council Vice-President Van Dzura commented that the southern border is a problem, there is no doubt about that, and both parties need to acknowledge that and come together to draw up the proper legislation to have the sufficient number of judges and workers to process those wanting to come in properly vet the people wanting to come and live here or determine if they need to be sent back. He went on to say that this is not a one-party issue to which Ms. Arrabito interrupted him to say that we have no one protecting our borders and that is because of our current president and not having the proper funding in place. Council President Cohen asked for order and if Ms. Arrabito had any additional items she would like to discuss to which she stated that she was waiting for an answer to her earlier question first; she then thanked Councilman Dipierro for acknowledging Italian Heritage Month.

Anjan Karnati, 11 Preservation Dr. – Mr. Karnati asked if anyone on Council is in charge of the school facilities; Administrator Weinberg answered that school facilities are overseen by the Board of Education. Mr. Karnati stated that it is understood that the schools are separate and overseen separately by the Board of Education but the resident's quality of life is the responsibility of the Township to which Council President Cohen answered that the Board of Education is responsible for the education of our students and we care about all our students attending our schools. Mr. Karnati went on to say that prior to the Township giving any approvals for developments there should be a meeting between the Planning Board and Board of Education as the schools are overcrowded and not sufficient to handle the influx of students that attend. Administrator Weinberg responded that whenever requested by the Board of Education, himself along with the Planning Director have met with them explaining that 96% of all development that is slated is part of the court ordered affordable housing settlement, such as the Lofts at Monroe Parke, Stratford and Georgetown Estates to name a few. Administrator Weinberg suggested to Mr. Karnati that he take a look at the long-range plans regarding the school facilities as we share all our information with the Board of Education so they could plan accordingly and are responsible for producing the demography and his follow through would be best with them.

<u>Tim Eosso, 625 Spotswood-Gravel Hill Rd.</u> – Mr. Eosso read a statement into the record regarding overdevelopment, impact fees and election contributions received from engineers and developers that have negatively impacted our Township and have contributed to its overdevelopment.

Mr. Eosso commented about the migrants coming to Monroe, stating that the Township does not own the Boy's Home but the State does, adding that Council Vice-Present Van Dzura was very upset at a resident last month for questioning it and feels an apology is owed to Mrs. Arrabito. Mr. Eosso went on to question what the Township's plan is for handling the migrants as the residents of the Township deserve a Mayor and Council who will fight for them and give them answers. Administrator Weinberg responded saying that

the Citizen's Review Board had their semiannual meeting a week ago where representatives of the Boy's Home gave updates as to the ongoings of the facilities and Board Member Pete Piro asked directly to the representatives if there were any plans of having migrants move into the facility to which the representatives emphatically stated that this was an active site with no plan to have any migrants move in there adding that this was the first they have heard of such a thing.

Adam Durando, 66 Ave K — Mr. Durando asked what we are doing as a Township to lower costs for all residents to live here; he went on to state that we come in second for having the lowest tax rate but not first and asked what is being done to make it more affordable for all to stay here not just the seniors over 65 because 40% of the residents here are between the 18-65 age range; Administrator Weinberg commented that Mr. Durando brings up some great points and clarified that the Township has done a tremendous effort in trying to keep the tax rate low which it is lower today than it was in 2020 as well as the school budget being lower than it was in 2020 due in part to fighting for additional school aid. Administrator Weinberg explained that the ANCHOR program is available to everyone over the age of 18 who makes less than \$250,000 and STAYNJ is a work in progress but a good program as well. He went on to state that Mayor Dalina has been working towards expanding the senior freeze program and maintaining affordability by keeping our taxes stable and refinancing our debts. Mr. Durando commented that keeping our taxes stable does not mean making them lower it simply just means that we are keeping them flat and the ANCHOR and STAYNJ programs are not done by the Mayor and Council but offered by the State to which Council President Cohen explained that Mayor Dalina was asked to testify in support of those programs to help pass these bipartisan bills.

<u>Harold Kane, 480-B Newport Way</u> – Mr. Kane stated that he is a Vietnam vet and part of Post #401 locally and commented that the veteran's housing project is 80 units and a mix of 1, 2 and 3 bedrooms to which veterans have no use for a 3-bedroom unit; adding that the number of veterans coming to NJ is way down. He asked for clarification as to how many units there will be as he has heard it is an 80-unit development but now hears it is only 37 units. Administrator Weinberg explained that 37 units are for veteran's only and the other 43 are veteran's preference. Mr. Kane asked if there were any amenities to which Administrator Weinberg answered that there will be community meeting rooms, a social service agency, as well as a medical facility with a social worker who focuses on veteran's needs.

<u>Brian Fabiano, 19 Patricia Pl.</u> – Mr. Fabiano commented that someone mentioned "vicious cycle", and we have a yearly vicious cycle whereas a few people come out to try and gain voters year after year. They will attend a few meetings right before the Election and then after the Election you never see them again. The facts remain that you can see what this Council does.

Mr. Fabiano stated that the rumors of migrants coming to an active prison are all fallacies and bizarre. We see one team attack another team; He went on to say that Team Dalina does not go to that level but instead talks about things that have been accomplished such as the BFI landfill, Veterans Housing, increase in senior programs, more parks, recreation facilities and activities and that says a lot.

<u>Pat Schwalje</u>, 586A <u>Madison Dr. – Mrs. Schwalje</u> commented that our local election is very important and we need to stick with the local issues. As for transparency, we have it, as well as a beautiful website.

Mrs. Schwalje commented that there has been a pattern of abstentions by one particular person who abstains every meeting and she wants to know why. Attorney Gordon responded explains and state it is not appropriate. Mrs. Schwalje stated that if transparency is an issue than we should know the reason for the abstention.

<u>Michelle Arminio, 9 Nathaniel St.</u> – Mrs. Arminio commented that she sees faces being made and Council should not be laughing at the public. She went on to say that she wants to thank Councilman Dipierro because he focuses on the day to day needs for the Township, as well as works on protecting our quality of life in the Township. She added that she asks that more decency is given all around.

Mrs. Arminio stated that she would like to see the issue with the server resolved so the cable channel is accessible to everyone as it is good for our Township and its transparency.

Lastly, she stated that we should all continue to be respectful of each other.

<u>Beth Dipierro</u>, 404 Spotswood-Gravel Hill Rd. – Mrs. Dipierro apologized to everyone for her outburst from the audience, adding that she just wants all to be treated fairly.

UPON MOTION made by Councilwoman Siegel and seconded by Councilman Dipierro, the **PUBLIC COMMENTS** portion of the Meeting was closed. All were in favor, none opposed.
