- (2) Regulatory and warning signs shall be erected and maintained to effect the above designated speed limits authorized by the Department of Transportation.
- D. Tow away zones. Any vehicle parked or standing as to obstruct or impede a normal flow of traffic, block entrances or exit ways, loading zones, oil fills, any grassy area, pedestrian walkway, or present in any way a safety or traffic hazard may be removed by towing the vehicle at the owner's expense.
- E. That all signs, posts, or other necessary materials be installed, paid for, and maintained by the Association. All signing shall conform to the current Manual on Uniform Traffic Control Devices, pursuant to N.J.S.A. 39:4-198 and N.J.S.A. 39:4-183.27.
- F. Penalty. Unless another penalty is expressly provided by New Jersey Statute, everyperson convicted of a violation of this section or any supplement thereto shall be liable to a penalty of not more than \$50 or imprisonment for a term not exceeding 15 days or both.

Lastly commented that he has a streetlight out on his road, and he reported it 2 months ago to JCP&L and still no response from them.

<u>Gary Busman, 7 Monarch Rd.</u>—Mr. Busman commented that approximately 3 years ago we discussed the Veteran's Housing Project and asked why it has not begun being built; Administrator Weinberg answered that the plans are finished and there is a meeting in two weeks to go over. Mr. Busman commented that this is very important to have done.
