Upon payment in full, the Township Clerk's office shall supply the purchaser with the following items: a fully completed and signed OS/SS-88 Form; a certified affidavit of newspaper publication of the auction; and a bill of sale from the Township containing the sale price, sale date, purchaser's name, address and signature and the Township's address, authorized representative's name and signature. In order to obtain title to the vehicles, it shall be the purchaser's responsibility to mail the above documents with a \$3.00 check or money order made payable to the MJMVC, together with a check in the amount of 6.625% sales tax on the purchase price of the vehicle, and a photocopy of the purchaser's driver's license to the MVC, P.O. Box 017, Trenton, New Jersey 08666-0017.

All sales shall be final and the vehicles are sold in "as is or where is" condition free from any warranty or guarantee.
